<u>Water Rates:</u> There are two sets of rates, depending upon whether your property's raw water requirement was satisfied with the Fort Collins – Loveland Water District or the City of Fort Collins at the time your tap was purchased. Water rates include a base fee and tiers for consumption. The Water Resource Surcharge is for Commercial and Irrigation customers only. It is charged per 1,000 gallons.
